With reference to the above, in the wake of outbreak of COVID-19, Election to the Board of Directors of the Jackson Co-operative Credit Society of the Employees of the Western Railway Ltd. which was to be held on 26.03.2020 was postponed till further orders vide letter no.2 cited above.

Further Director(Co-operation) Central Registrar of Co-operative Societies, New Delhi vide Circular No.F.No.R-11017/01/2015-L&M dated 14.09.2020 has directed that Multi-State Co-operative Societies are allowed to conduct their Elections in the conventional way till 31.12.2020 or earlier depending upon the situation.

Further, the following broad guidelines should be followed on the day of polling by all divisions:

- i. Every person shall wear face mask during every election activity.
- ii. At the entry of hall/room/premises used for election purpose:
 - (a) Thermal scanning of all persons should be carried out.
 - (b) Sanitizer, soap and water shall be made available at all polling stations.
- iii. Social-distancing shall be maintained as per the extant COVID-19 guidelines of respective State Government and Ministry of Home Affairs.
- iv. As far as possible, large halls should be identified and utilized to ensure social distancing norms.
- v. Mandatory sanitization of polling station, preferably, a day before the poll.
- vi. Face masks in reserve should be kept for those electors who are not carrying the.
- vii. Awareness posters on COVID-19 should be displayed at visible locations.
- viii. Sitting arrangement in polling station for polling personnel shall be made as per the norms of social distancing.
- ix. During the process of identification of voter, the voters will be required to lower the facemask for identification, when required.
- x. Sanitizers will be kept inside the booth at appropriate locations with clear directions for the use of voters.
